I/We understand that I/we will be charged a fee as per the bylaws of the Sheppton-Oneida Volunteer Fire Company, and that, in additional consideration for allowing me/us to use the facility, the Sheppton-Oneida Volunteer Fire Company expects that I/we will be legally responsible for all that may occur relative to my/our activities, and that I/we will further hold the Sheppton-Oneida Volunteer Fire Company harmless for all claims of any type that might result from my/our activities. Specifically, I/we understand:

1. The Sheppton-Oneida Volunteer Fire Company does not supervise my/our activities or the facilities in any fashion including the service of alcohol. I/we certify that all activities will be in full compliance with any local, state, and federal laws and/or regulations. I/we will hold the Sheppton-Oneida Volunteer Fire Company harmless in any claims, actions, or lawsuits that result from the service of alcohol, even if claims relate to the legal service of alcohol.

2. I/We cannot rely upon the Sheppton-Oneida Volunteer Fire Company for assurances, expressed or implied, that my/our activities will not cause harm to myself/ourselves or others. By allowing me/us to utilize the facility, the Sheppton-Oneida Volunteer Fire Company is also making no assurances whatsoever that no harm will come to myself/ourselves, my/our invitees, my/our guests, or the general public by my/our activities, or by the facility itself. I/We our fully responsible to ensure that the facility is adequate to engage in my activities safely, and in the even that I/we deem that the facility is not, I/we will refrain from any activities. This will be my/our sole responsibility.

3. I/We understand the activity I/we engage in and the risks associated with the activity. The Sheppton-Oneida Volunteer Fire Company provides me with no information in this regard, and that in the case that I/we are not able to hold the activity safely, I/we will refrain from any activities. This will be my/our sole responsibility.

4. Not only do I/we agree to be legally responsible and defend, indemnify, and hold harmless the Sheppton-Oneida Volunteer Fire Company or any of their agents or employees for any harm that may come to myself/ourselves, my/our guests, and the general public as a result, direct or indirect, to me/us as a result of the activities or as a result of the use of the facilities, but in consideration of the use of the facility, I/we further agree to defend, indemnify, and hold harmless the Sheppton-Oneida Volunteer
